**PRIVACY NOTICE**

1. **Collection of Personal Data**

This Privacy Notice is pursuant to the Personal Data Protection Act 2010.

We treat and view your personal data seriously.

In the course of your dealings with us, Pan Malaysian Sweeps Sdn Bhd and its related corporations (as defined under the Companies Act 1965) ("PMS Group"), we may collect process use store and/or disclose data and information about yourself ("Personal Data").

2. **Nature of Personal Data**

- c. delivering notices, services, products, prizes (where applicable), updates and/or promotional materials to you;
- d. maintaining and improving customer relationship;
- e. communicating with you;
- f. market / demographic research and marketing contest held by PMS Group;
- g. conducting marketing survey and client profiling activities;
- h. maintaining and updating internal record keeping;
- i. publishing in any mass media or marketing materials for advertising or publicity purposes;
- j. detecting and preventing crime (including but not limited to fraud, money-laundering, bribery); and/or
- k. meeting any legal or regulatory requirements and making disclosure under the requirements of any applicable law, regulation, direction, court order, by-law, guideline, circular, code applicable to us or any entity within our group.

6. **Disclosure**

The Personal Data provided to us will generally be kept confidential but you hereby consent and authorize us to provide or disclose your Personal Data to the following categories:-

We endeavour, where practicable, to implement the appropriate administrative and security safeguards and procedures in accordance with the applicable laws and regulations to prevent the unauthorized or unlawful processing of the Personal Data and the accidental loss or destruction of, or damage to, the Personal Data.

8. **Rights of Access and Correction**

8.1 You have the right to request for access to and correction of your information held by us and in this respect, you may:

- a) check whether we hold or use your Personal Data and request access to such data;
- b) request that we correct any of your Personal Data that is inaccurate, incomplete or out-of-date;
- c) request that your Personal Data be retained by us only as long as necessary for the fulfilment of the purposes for which it was collected;
- d) request that we specify or explain our policies and procedures in relation to data and types of Personal Data handled by us;
- e) communicate to us your objection to the use of your Personal Data for marketing purposes whereupon we will not use your Personal Data for these purposes; and
- f) withdraw, in full or in part, your consent given previously, in each case subject to any applicable legal restrictions, contractual conditions and a reasonable time period.
