TERMS AND CONDITIONS OF THE JACKPOT PRIZE
(VALID UNTIL END OF DRAW 7/23, DRAW DATE 4 JUNE 2023)

1. DEFINITIONS

In these terms and conditions, unless the context otherwise requires:-

“Big Sweep Conditions”	:	means the amended and restated terms and conditions governing the Big Sweep dated 24th September 2021.
“Big Sweep Draw”	:	means a draw held at such intervals as decided by PMS, to determine the winner(s) of the Big Sweep.
“Big Sweep First Prize”	:	means the first prize of the Big Sweep as determined in accordance with the provisions of the Big Sweep Conditions.
“Big Sweep Second Prize, Third Prize, Fourth Prize, Fifth Prize and Sixth Prize”	:	means the second, third, fourth, fifth and sixth prizes of the Big Sweep as determined in accordance with the provisions of the Big Sweep Conditions.
“Big Sweep”	:	means the Big Sweep game, the terms of which are as set out in the Big Sweep Conditions dated 24th September 2021.
“Effective Date”	:	means the date the Tickets for Draw 18/21 are released for sale to the public or such other date as may be notified by PMS in accordance with Clause herein.
“Initial Jackpot 1 Prize”	:	means the amount of RM1,000,000.00 for Jackpot 1, as determined by PMS from time to time at its sole and absolute discretion.
“Initial Jackpot 2 Prize”	:	means the amount of RM200,000 for Jackpot 2, as determined by PMS from time to time at its sole and absolute discretion.
“Jackpot 1”	:	means the amount of Jackpot 1 Prize that is payable to the bearer or bearers of the winning Ticket determined in accordance with terms and conditions herein.
“Jackpot 2”	:	means the amount of Jackpot 2 Prize that is payable to the bearer or bearers of the winning Ticket or Tickets determined in accordance with terms and conditions herein.
“Jackpot 1 Prize”	:	means the amount which is the sum total of the Initial Jackpot 1 Prize and any accumulation of the Initial Jackpot 1 Prize of previous draw(s) not won (if any) provided that the Jackpot 1 Prize may be varied, altered and/or modified by PMS from time to time at its sole and absolute discretion in accordance with Clause 4.
“Jackpot 2 Prize”	:	means the amount which is the sum total of the Initial Jackpot 2 Prize, any accumulation of the Initial Jackpot 2 Prize of previous draw(s) not won (if any) and the amount cascaded from Jackpot 1 Prize in accordance with Clause 3.2.3 provided that the Jackpot 2 Prize may be varied, altered and/or modified by PMS from time to time at its sole and absolute discretion in accordance with Clause 4.
“Jackpot Prize”	:	means the Jackpot 1 Prize and the Jackpot 2 Prize, as the case may be.
“Jackpot Prize Number”	:	means one (1) number selected from the Pool of Numbers.
“PMS”	:	means Pan Malaysian Sweeps Sdn Bhd.
“Pool of Numbers”	:	means the pool of numbers from which the Jackpot Prize Number is drawn from, the numbers of which are represented by differing numerals contained therein. The Pool of Numbers shall be represented by differing numerals in a range of numbers, each of which as depicted on balls contained in the said pool.
“Tickets”	:	means the Big Sweep tickets.
“Turf Clubs”	:	means collectively the Penang, Perak and Selangor Turf Clubs.
“Winning Jackpot Prize Number”	:	means the number as marked on the ball successfully drawn as the winning Jackpot Prize Number.

2. DRAWING OF WINNING JACKPOT PRIZE NUMBER

- 2.1** Each Ticket shall bear one (1) number represented by a numeral in the same range as that of the Pool of Numbers.
- 2.2** One (1) ball shall be drawn from the Pool of Numbers to determine the Winning Jackpot Prize Number. The number as marked on the ball as successfully drawn shall be adjudged and determined to be the Winning Jackpot Prize Number.
- 2.3** The draw for the Winning Jackpot Prize Number shall be conducted at such date, time and place and in such manner as shall be determined by PMS.



3. JACKPOT PRIZE

3.1 There are Jackpot 1 Prize and Jackpot 2 Prize. The Jackpot 1 Prize starts with an Initial Jackpot 1 Prize of RM1,000,000.00 per draw. The Jackpot 2 Prize starts with an Initial Jackpot 2 Prize of RM200,000.00 per draw.

3.2 Jackpot 1 Prize

- 3.2.1 The Jackpot 1 is payable to the number drawn as the Big Sweep First Prize and bearing the Jackpot Prize Number which matches the Winning Jackpot Prize Number.
- 3.2.2 In the event the Jackpot Number of the Big Sweep First Prize for any Big Sweep Draw does not match the Winning Jackpot Prize Number, there shall not be a winner of Jackpot 1 for that particular Big Sweep Draw and the Jackpot 1 Prize shall, subject to Clause 3.2.3, accumulate and be added to the Jackpot 1 Prize for the next Big Sweep Draw(s).
- 3.2.3 When the Jackpot 1 Prize for a particular Big Sweep Draw exceeds RM20.0 million and there is no winner for Jackpot 1 for that particular Big Sweep Draw, the amount in excess of RM20.0 million from Jackpot 1 Prize will be cascaded and added to and form part of the Jackpot 2 Prize for the next Big Sweep Draw, which will henceforth be applied in accordance with the provisions for Jackpot 2 Prize, and only RM20.0 million will be accumulated and added to the Jackpot 1 Prize for the next Big Sweep Draw.
- 3.2.4 Upon the amount in Jackpot 1 being won in accordance with the provisions herein, the Jackpot 1 Prize shall, for the Big Sweep Draw immediately thereafter, revert to and commence at the Initial Jackpot 1 Prize.

3.3 Jackpot 2 Prize

- 3.3.1 The Jackpot 2 is payable to the numbers drawn as the Big Sweep Second Prize, Third Prize, Fourth Prize, Fifth Prize and Sixth Prize and bearing the Jackpot Prize Number which matches the Winning Jackpot Prize Number drawn, to be shared equally if there are two or more matching combinations and to be paid to that number if only one of the Big Sweep Second Prize, Third Prize, Fourth Prize, Fifth Prize and Sixth Prize whose Jackpot Prize Number matches the Winning Prize Jackpot Number.
- 3.3.2 In the event the Jackpot Prize Number of each of the Big Sweep Second Prize, Third Prize, Fourth Prize, Fifth Prize and Sixth Prize for any Big Sweep Draw does not match the Winning Jackpot Prize Number, there shall not be a winner or winners of Jackpot 2 for that particular Big Sweep Draw and the Jackpot 2 Prize for that particular Big Sweep Draw shall, subject to Clause 3.3.3, accumulate and be added to the Jackpot 2 Prize of the next Big Sweep Draw(s).
- 3.3.3 When the Jackpot 2 Prize for a particular Big Sweep Draw exceeds RM10.0 million and there is no winner (s) for Jackpot 2 for that particular Big Sweep Draw, the amount in excess of RM10.0 million will be shared equally among the Big Sweep Second Prize, Third Prize, Fourth Prize, Fifth Prize and Sixth Prize for that particular Big Sweep Draw, and only RM10.0 million will be accumulated and added to Jackpot 2 Prize for the next Big Sweep Draw.
- 3.3.4 Upon the amount in Jackpot 2 being won in accordance with the provisions herein, the Jackpot 2 shall, for the Big Sweep Draw immediately thereafter, revert to and commence at the Initial Jackpot 2 Prize.

4. VARIATION OF JACKPOT TERMS

PMS reserves the right to, at any time and/or from time to time, vary, alter and/or modify the amounts stated as the Initial Jackpot 1 Prize, the Jackpot 1 Prize, the Initial Jackpot 2 Prize, the Jackpot 2 Prize and/or the Pool of Numbers by providing notice of such variation, alteration and/or modification at the premises of PMS or through publication in the official social media account of PMS and/or local newspapers.

5. GENERAL

- 5.1 Any claims for payment in respect of a winning Ticket shall be made within six (6) months from the eighth day after the relevant Big Sweep is drawn, after which the Ticket is deemed to be cancelled and shall be declared null and void. All prize money in respect of such Ticket(s) shall thereafter accrue to PMS.
- 5.2 The Jackpot 1 Prize and the Jackpot 2 Prize as determined in accordance with Clause 3 above, may be claimed only at the designated administrative office of PMS as printed on the reverse side of each Ticket.
- 5.3 Tickets will be validated before payment. Torn, altered, tampered, mutilated, and disfigured Tickets shall not be entitled to any payment. Tickets which do not pass the validation procedures and security checks as determined by PMS shall not be entitled to any prize.
- 5.4 All relevant provisions of the Big Sweep Conditions, more specifically Conditions 6.3, 6.5, 6.7 and 7 shall apply herein mutatis mutandis and shall form an integral part of the provisions herein save that in the event of conflict between the provisions herein and the Big Sweep Conditions, the latter shall prevail.
- 5.5 Clause headings are for convenience only and shall not be taken into account in the construction of the terms herein.
- 5.6 These terms and conditions shall take effect from the Effective Date and shall from such date revoke and supersede any other terms and conditions previously applicable in respect of the Jackpot Prize.
